# **RULES AND REGULATIONS OF THE MID OHIO HOME SHOW 2019**

- 1. Fairgrounds will open for installation of exhibits from 9 a.m. until 7 p.m. on Thursday March 7 & Friday, March 8 , 9 a.m. until 1 p.m.**  
all items on display must be confined within the area of exhibitor's booth. Nothing may protrude in front of, beside or behind exhibitor's booth. Signs must be within normal backdrop of booth.  
Signs must be professionally made. Signs, displays or other items are not permitted to be taped or affixed in any manner to light poles, planter, walls or ceilings etc. No flashing signs.
- 2. The show will be open to the public and exhibitors will be in and responsible for their booths, 3 p.m. to 7 p.m., Friday, March 8, 9 a.m. to 7 p.m., Saturday March 9, 11 a.m. to 4 p.m., Sunday, March 10.**
- 3. Take** down and exhibit removal activities are restricted to the following periods: Sunday, March 10, 4 p.m. to 6 p.m. Monday, March 11, 8 am to 12 Noon
4. The MID-OHIO HOME SHOW Committee reserves the right to accept or reject any and all applications for the 2019 Mid-Ohio Show
5. Booth spaces will be 10 ft. by 10 ft. Specific location of an exhibitor's booth space(s) will be assigned by the show committee. Subletting booths is not permitted.
6. The exhibitor does hereby agree to have at least a Five Hundred Thousand Dollar (\$500,000) Liability Insurance Policy.
7. The Mid-Ohio Home Show shall not be responsible for damage of property, or loss due to theft, or the elements of fire, etc. The exhibitor shall be responsible for any damage he/she may cause to Richland County Fairgrounds.
8. It is expressly understood and agreed and the exhibitor agrees by accepting these rules, that he or she will make no claim of any kind against the Mid-Ohio Home Show, Optimist Club for any loss, damage, or destruction of goods, or for any injury that may occur to the exhibitor or his or her employees while in the Fair grounds.
9. If an exhibitor disregards any of these rules or is disruptive to the show in general or does not construct a quality exhibit, the Mid-Ohio Home Show reserves the right to break the lease immediately and ask the exhibitor to remove his materials, displays or exhibits from the Fairgrounds immediately.
10. All exhibits must be brought into the buildings with rubber tired handcarts or dollies unless prior approval has been obtained. No parking on sidewalks. No motor vehicles in the buildings or in restricted areas.
11. All exhibitors agree to abide by the Fairgrounds rules and regulations.
12. If it is necessary to cancel the Mid-Ohio Home Show for any reason, the liability of the Mid-Ohio Home Show, Mansfield Noon Optimist shall be limited to the return of any and all monies paid by the exhibitor.
- 13. All exhibitors will protect floor with carpet, plastic, etc., when installing stone, brick or other landscape materials.**
14. No food or beverage is to be sold or given away.

Exhibitor's booth must be completely installed and ready for show opening on Friday, March 8, by 1:00p.m.

All displays, exhibits and materials must be removed from the fairgrounds no later than 12 Noon, on Monday, March 11, 2019.

**NOTE: If any & all materials are not removed by this time, a \$75.00 per booth charge will be assessed to the exhibitor.**
